# Idat-Cars rose by 0.1% in July

- ▶ The Idat-Cars rose by 0.1% in July, maintaining a slight upward trend from June. The pace of the three-month average remained stable (0% MoM), while the index increased by 0.8% on an annual basis (YoY).
- ▶ Prices for new and used cars increased, while low-mileage vehicles declined. The breakdown shows that prices for new, low-mileage and used¹ cars changed by +0.2% MoM, -0.4% MoM and +0.3% MoM, respectively. In the three-month moving average, the new, low-mileage and used car group varied by 0% MoM, -0.3% MoM and +0.2% MoM, respectively.
- For new vehicles, the MoM increase was driven by electric and hybrid vehicles. Without this group, the index posted a -0.4% MoM (vs. +0.2% for the new cars group).


▶ Prices fell in the low-mileage car group. Prices for 1-year, 2-year, and 3-year-old cars closed at -0.9% MoM, - 0.4% MoM, and -0.3% MoM, respectively. Additionally, on an annual variation basis (YoY), 1-year-old cars continued to show the highest depreciation, recording a -4.9% YoY decline YoY, compared to -3.0% YoY for 2-year-old vehicles and -2.3% YoY for 3-year-old vehicles.



#### Idat-Cars - MoM var



### Idat-Cars breakdown MoM var and ma3m




Idat-Cars low-mileage MoM var and ma3m






